He explained that the preliminary budget must be submitted to the Franklin County Budget Commission by July 20, 2026, and that the proposed revenue projections reflect modest inflationary increases. Public comments were invited, and no comments were received.

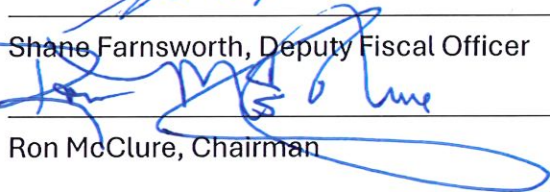
