Kevin Harr spoke and played a recorded private discussion.

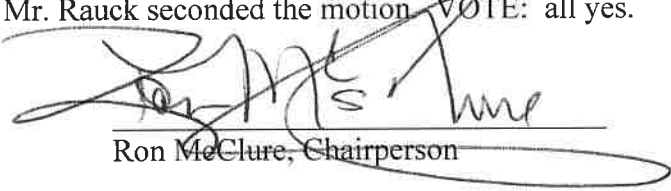
